OVERVIEW

For sale by private treaty, this mid-terraced industrial warehouse is of steel portal frame construction beneath a flat corrugated metal sheet roof. Concrete flooring can be found throughout, and access is via a roller shutter door. To the front is a secure gated yard enclosed by a brick wall and steel gates providing an ideal space for loading and manoeuvring.

Staff and visitor parking can also be found to the front elevation. Supporting accommodation at the ground floor level includes offices and WC facilities, while the first floor provides additional office space fitted with air conditioning, suspended ceilings, recessed lighting, carpet tiles, radiators, and double-glazed windows.

The property is located in Orton Southgate which is widely recognized as one of Peterborough's flagship industrial and business parks. Situated approximately 4 miles southwest of Peterborough city centre. The area benefits from excellent transport links with junction 17 of the A1 located less than a mile away providing exceptional north-south connectivity to key areas such as London and rapid access to the wider national motorway network. The A14 can also be found nearby and further enhances the connectivity of the area offering convenient links to the Midlands.
